PUBLIC HEARING ON
PROPOSED DESIRED FUTURE CONDITIONS (DFCs) GMA 2

Sandy Land Underground Water Conservation District (SLUWCD) is currently receiving public comments on the proposed Desired Future Conditions (DFCs) for area aquifers recently adopted by Groundwater Management Area 2, under §36.108 of the Texas Water Code.

Groundwater Management Area 2 (GMA 2) includes the following conservation districts: Garza County UWCD, High Plains Water District #1, Llano Estacado UWCD, Mesa UWCD, Permian Basin UWCD, SLUWCD, and South Plains UWCD.

The proposed Desired Future Conditions (DFCs) for the area aquifers and other related supporting materials are available for public viewing at the SLUWCD office at 1012 Avenue F, Plains, TX 79355 or online at www.gma2.org. 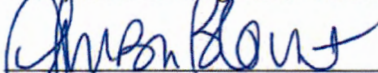
1. The President will call the SLUWCD Board of Directors meeting to order and establish a quorum.
2. The President will convene the public hearing.
3. The Board will receive public comment on the following:
 - a. Proposed DFCs for relevant aquifers in GMA 2:
 - i. A GMA 2-wide average drawdown of 23 feet between 2020 and 2080 for the Ogallala and Edwards-Trinity (High Plains) Aquifers.
 - ii. A GMA 2-wide average drawdown of 22 feet between 2020 and 2080 for the Dockum Aquifer.
4. The President will adjourn the public hearing and reconvene the SLUWCD Board of Directors meeting.

All interested members of the public are invited to attend. Any person who wishes to present comments or other information at the hearing may do so in person, by counsel, or both. Comments may be presented verbally or in written form. Limits may be placed on the amount of time that each person is allowed to present verbal comments at the hearing. The hearing posted in this notice may be recessed from day to day or continued where appropriate. Any person with a disability who needs special accommodations should call 806-456-2155.
